

TERMS AND CONDITIONS

- Customers can scan the QR Code at Plainland Plaza when \$10 or more is spent at a specialty store or \$50 or more at Woolworths in one transaction on any one day.
- 2. Customers must attach and retain their purchase receipt as proof of purchase in case they win.
